

Contract

Cheer Energy All-Stars is committed to giving youth a place to excel, gain strength & confidence and to learn teamwork and sportsmanship. This contract is devised to ensure that each participant in Cheer Energy All-Stars upholds the Energy Standards while using the Cheer Energy Athletics Facility and while representing the organization at competitions and gym functions. **Parents and cheerleaders please read and initial each line and sign below.**

____ I understand that it is my responsibility to be a strong representative and ambassador for the Cheer Energy All-Stars program. I understand I must display a positive attitude at all times and respect all teammates and coaches. I understand that abusive, uncontrollable or irresponsible behavior of any kind will result in termination of my membership on a Cheer Energy All-Stars team.

____ I understand that I must complete WAIVERS for CEA in order to participate in any activity in the Cheer Energy All-Stars facility or to represent CEA outside the facility, in addition to any other necessary paperwork.

____ I understand that it is the policy of Cheer Energy All-Stars to prohibit harassment of any kind. No one is to harass another individual on Cheer Energy All-Stars premises.

____ I understand that Cheer Energy promotes a positive program and that **negativity will not be tolerated** in the **gym, lobby, at competitions or on any form of social media**. I understand that I must follow all gym rules while in the Cheer Energy All-Stars facility. I understand that foul language, indecent exposure and inappropriate conduct are not allowed and may result in the removal of myself or my child from the program.

____ I understand that as a member of Cheer Energy All-Stars I will have ample opportunities to progress skills in tumbling; therefore, I agree NOT to participate in gymnastics/tumbling/cheer training in any cheerleading facility within a 50-mile radius of the Cheer Energy All-Stars facility.

____ I understand that it is my responsibility to be at all practices and ALL competitions. I understand that Cheer Energy has an attendance policy as outlined in the handbook and agree to abide by it. *If I miss more than three practices in a semester (Aug- Dec and Jan - April) for any reason, I may be replaced or removed from the team at the decision of the coaches/owners.* Competition cheerleading is a team sport with each member having a specific job. I understand that if I/my child is not present it creates a burden for the rest of the team members who depend on him/ her.

____ I understand that I will be required to pay all fees regardless of when I/ my child joins the team (registration fee, choreography/music fee, USASF fee, tuition, etc) and all competition fees even if my child does not compete due to illness, absence unless otherwise agreed to by the owners due to prolonged injury. If a substitute is necessary, the injured/absent cheerleader will pay the necessary fee.

____ I understand that **all fees are non-refundable**. I agree to pay all fees on time thru automatic withdrawal or pay the year in full on the date due. I understand that if there are insufficient funds to pay my account or I am delinquent on my account, I understand Cheer Energy All-Stars may remove my child from the team or have them sit out until such fees are paid. I understand that if all competition fees are not paid by the first competition date, my child will not be allowed to compete with their team.

____ PARENTS: If I withdraw from the program or need to stop/change my draft, I understand that I must give a 30 day WRITTEN notice to stop/change the ACH draft.

____ PARENTS: I understand that my presence inside the training area presents a **liability** issue. I further understand that I may enter the training area if and only if I am invited by a coach to view a routine or skill. I understand that coaches may close practice at any time and for any reason.
